- Electronic bids must be submitted to the Department of Plant Resources, Thapathali, Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp before or on 12.00 pm on 2079/11/14. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00 pm on 2079/11/14 at the office of Department of Plant Resources, Thapathali, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening (till 2080/02/12) and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of NRs.60,000.00 (In words rupees sixty thousand only), which shall be valid for minimum 30 days beyond the validity period of the bid (i.e. till 2080/03/10).
- The Bidders, who choose to deposit the bid security in the form of cash, should deposit it in the Security Deposit Account of District Treasuary Office, Babarmahal, Kathmandu, Deposit Account No. 1201200001002524, Office Code No.: 329023501 (2732903) at Nepal Rastra Bank, Baluwatar, Kathmandu and submit the scanned copy of receipt of the deposited amount of cash in pdf format along with the bid.
- The bid security issued by a Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing law of Nepal is also acceptable.
- 8. If the last date of purchasing, submission and/or opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
- The attached catalogued for the offered goods must be genuine and must be verifiable through direct online links (urls) for the catalogues of each and every offered goods (except accessories) at the authentic official website of the manufacturer. Such urls must be provided by the bidder, where required, in the bid document. The bids, whose catalogues cannot be verified online at the authentic official website of the manufacturer, will be evaluated as "omission" for all the technical clauses.
- 10. Rotary Evaporator, Heating Bath, Chiller and Vacuum pump must be manufactured by the same manufacturer.
- 11. The Department of Plant Resources reserves the right to accept or reject any or all the bids without assigning reason, whatsoever.
